



ADVANCED VIOLENCE RISK ASSESSMENT AND MANAGEMENT WORKSHOP

Protect International is pleased to present a 5-Day Advanced Violence Risk Assessment and Management Workshop in Toronto, Ontario. The workshop is taking place between 30 September-4 October 2019.

This Workshop will provide professionals with high-level skills related to risk assessment and management and an opportunity to demonstrate their mastery when implementing these skills into practice. A special emphasis will be placed on advanced issues related to sexual violence and intimate partner violence for this Workshop.

Topics covered will include: 1) advanced principles of risk assessment and management, including case formulation and scenario planning; and 2) advanced skills related to report writing, risk communication, expert testimony, violence triaging, information sharing, use of multiple tools, and parallel investigations.

DAY 1

Advanced principles of violence risk assessment and management

- Discuss advanced violence risk assessment and management principles, including case formulation and scenario planning
- Practice case formulation and scenario planning with sample cases

DAY 2

Writing short reports

- Discuss core components of writing short reports
- Review case #1 and administer the HCR-20 V3
- Write short report based on case #1

DAY 3

Writing long reports

- Discuss core components of writing long reports
- Review case #2 and administer the HCR-20 V3
- Write long report based on case #2

DAY 4

Communicating oral reports and conducting expert testimony

- Discuss core components of risk communication
- Practice oral report based on case #2
- Discuss general principles for conducting expert testimony
- Practice expert testimony based on case #2

DAY 5

Implementing violence risk assessment and management procedures

- Discuss legal issues (e.g., human rights, privacy and information sharing, occupational health and safety)
- Discuss implementation of violence risk assessment tools (e.g., multiple tools, parallel investigations, threat assessment teams)

Daily Schedule

The workshop runs from 0900 to 1630 each day, with refreshment breaks in the morning and afternoon and a lunch break from 1200 to 1300. Registration is from 0830 to 0900 on the first day of the workshop.
