FOUNDATIONAL VIOLENCE RISK ASSESSMENT AND MANAGEMENT WORKSHOP

Protect International is pleased to present a 5-Day Foundational Violence Risk Assessment and Management Workshop. The workshop is taking place between 2 – 5 October 2023 in Vancouver.

This workshop will provide an opportunity to learn new skills and build on existing skills in assessing and managing risk for violence. Not only will you learn about general violence risk assessment and management principles focusing on the most common forms of violence, but also about best practices supported by researchers and practitioners around the world. Successful completion will be recognized with a certificate.

The specific tools you will learn to administer include the new versions of the HCR-20 and SARA, as well as the B-SAFER and SAM. All of these tools are structured and evidence-based and amongst the most widely used procedures for assessing and managing violence risk.

Thousands of professionals from hundreds of settings across the world have taken part in our workshops to date and the procedures developed by our Threat Assessment Specialists are among the most widely used in the field. Our Violence Risk Assessment and Management Workshops are the only ones in this field that have been subjected to systematic empirical research and evaluations indicate that the vast majority of participants recommend our workshops.

WHO SHOULD ATTEND?

This workshop is designed for professionals whose work involves risk assessment and management, including those working in criminal justice, security, victim services, forensic mental health, civil mental health, general health care, social services, human resources, occupational health and safety, and legal services.

Workshop Overview

DAY 1

Violence triage and implementation issues

- Focuses on triaging for violence risk to determine when comprehensive assessment is necessary
- Focuses on legal issues (e.g., human rights, privacy and information sharing, occupational health and safety)

DAY 2

Principles of violence risk assessment and management

- Focuses on the nature of violence and violence risk
- Reviews principles of violence risk assessment, focusing on structured professional judgment (SPJ) approaches
- Reviews principles of violence risk management, focusing on scenario planning approaches

DAY 3

Assessing and managing risk for general violence

- Focuses on general or “typical” violence, including that committed by people with mental health, personality, or substance use problems
- Includes administration of the Historical-Clinical-Risk-Management-20 Version 3 (HCR-20 V3)

DAY 4

Assessing and managing risk for intimate partner violence

- Focuses on violence against current or former intimate partners, one of the most common and dangerous forms of violence
- Includes administration of the Spousal Assault Risk Assessment Guide Version 3 (SARA-V3) and the Brief Spousal Assault Form for the Evaluation of Risk (B-SAFER)

DAY 5

Assessing and managing risk for stalking

- Focuses on unwanted contact and communication, including physical violence, by people who are angry or obsessed
- Includes administration of the Guidelines for Stalking Assessment and Management (SAM)

Daily Schedule

The workshop runs from 9:00 am to 4:30 pm (PST / Vancouver, BC, Canada) each day with 1-hour lunch break and two 15-minute breaks.

Successful completion will be recognized with a certificate of completion for each participant.
