WHY ATTEND?

Stalking (also referred to as obsessional following, harassment, and bullying) includes incredibly diverse behaviour, can be challenging to identify, and has a tremendous impact on victims. This workshop is the official European launch of the newest version of the Stalking Assessment and Management Guideline (SAM), a structured professional judgement guideline for assessing and managing risk for stalking. Significant updates have been made to the guidelines, reflecting advances related to research, practice and the law and incorporating feedback from diverse professionals around the world.

This workshop is designed for professionals whose work involves risk assessment and management, including those working in criminal justice, security, victim services, forensic mental health, civil mental health, general health care, social services, human resources, occupational health and safety, and legal services.
